Third list: Enlisted men below grade 10. (Changes 74 to Par. No. 9, A. R.) arranged according to the usual formation of the company, that is, by squads. These names should be numbered consecutively beginning with No. 1.

To be filled in by Organization: Give full name of organization including company and regimental designation. Item Number.

To be filled in by Passenger Traffic Bureau: Name of Transport or Commercial Steamer. Date of Sailing. Item No. 661 Y. Part.
