Minutes of the previous meeting were read and approved upon motion by Bonita Mangrum seconded by Reba Prater.

#### Treasurer's Report

Treasurer Allen Jaco presented an in-depth year-to-date review of the Association finances, revealing a balance in the treasury of \$4,080.60 as of March 31, 2013.

#### **COMMITTEE REPORTS**

Membership - Allen Jaco reported 20 renewals and one new member in March. We now have 3 complimentary, 3 exchange, 3 honorary life members, 89 current (including 2 new) and 13 people receiving newsletters only, for a total of 113 members. Allen asked all members to complete a membership form so that our records could be updated as to address, telephone, e-mail and names of families being researched. Programs - Chmn. Marion Speaks advised that the May meeting will feature Wayne Wolford speaking about his new book, Through Wolf's Eyes, while Barbara Bates will present her family's genealogy. In June, Reba Prater will tell us about the United Daughters of the Confederacy. Christine Bouldin agreed to present genealogy information about the O'Neal family in June. Bonita Mangrum volunteered to present genealogy information for July with Allen Jaco volunteering for August. Publicity - Chmn. Mingle is keeping all media sources notified of our activities. In addition, Marion Speaks and Allen Jaco were recently featured on local radio with a program about WCGA.

**<u>Research</u>** – Chmn. Bonita Mangrum commented that she has recently visited Cocke County's archives and found that their records extend back only to 1870. She noted that Warren County is fortunate to have so many archival newspapers and records going back much farther. **<u>Office</u>** – Evelyn Wade presented information about available printers to be considered to replace our office printer. A decision on this will be taken up by the Board of Directors.

<u>**Bulletin**</u> – Editor Chris Keathley announced that the June Bulletin will likely be available by the time of the May meeting.

<u>Newsletter</u> – Editor Doyle Speaks told the group he will be adding a column featuring names of members and the families they are researching to promote sharing of information among members. This information will also be added to future Bulletins.

## **Sharing our Family History**



## Reba Prater talks about her John VanHooser Ancestor

Reba presented a most interesting history of her g-g-grandfather, John VanHooser, and the very unusual events of his military service in the 16th TN Infantry Regiment CSA during the Civil War.

John VanHooser was born on Nov. 21, 1837 and died November 24, 1929. He first enlisted on May 18, 1861 with the Donaldson Brigade, 4<sup>th</sup> Battalion, Co. (A) – E C.S.A. at Camp Harris, in Murrays Co., TN. This regiment was in 14 major skirmishes in 1861.

He suffered an arm wound on October 8 in Perryville, KY. and on June 13 he was promoted to Sargent. He was captured at Hillsboro, TN on June 28.

He spent 9 months as a POW and in February 1864 became part of an exchange of prisoners and was sent to Decatur, GA for instructions.

He suffered a foot injury in the battle of Atlanta and was captured again on November 29 at Central R.R. and escaped.

Once again he suffered an injury in the leg and was captured overnight only to be rescued by the Calvary the next morning near Murfreesboro, TN.

At the time of the surrender in 1865 he was in Greensboro, NC where he was parolled. He never took the oath of allegiance then or later.

In 1866 he lost 150 acres of his land to carpet baggers and in 1868 he lost his remaining 200 acres.

John VanHooser is buried at the Webb Cemetery in Warren County, TN.
