## **MINUTES IN BRIEF**

From the November 16, 2013 Meeting

### Call to Order

### Minutes

Since there was no October meeting, the September minutes were read and approved upon motion by Wilma Davenport seconded by Ladye Jane Hunter.

### **Treasurer's Report**

Treasurer Allen Jaco presented an in-depth review of the Association's finances for the previous month, listing \$54 in income, \$323.52 in expenditures, and balance of \$3,302.70.

#### **COMMITTEE REPORTS**

**Membership** – Allen Jaco reported no change in membership since September 31, 2013. The Association currently has 122 members.

**Circulation** – Chmn. Wilma Davenport distributed the Fall/Winter WCGA Bulletins to those present, indicating the rest will be mailed on Monday.

**Programs** – Chmn. Marion Speaks advised that the January 18 program will be Show & Tell as well as presentation of the remaining Pioneer Family Certificates. She requested members to be thinking about interesting items to bring for show and tell.

**Publicity** – President Mingle continues to keep local news media, including newspapers and radio announcements, abreast of our activities.

**Research** – Chmn. Bonita Mangrum noted that she had responded to two queries this month.

**Office** – Co-chmn. Evelyn Wade thanked Monty Wanamaker for the donation to our WCGA library of his book, Born a Country Girl, the Life & Legacy of Dottie West, as well as his 2014 Calendar featuring historic buildings in Warren County. These are for sale at Southern Museum.

**Bulletin** – Editor Chris Keathley announced that he plans to have the Spring/Summer Bulletin ready for distribution at the May meeting of the Association.

**Newsletter** – Editor Doyle Speaks was once again congratulated on his fine work on the Newsletter. He continues to ask for email addresses for anyone that members would like to add to the Newsletter distribution.

**Webpage** – Administrator Pat Berges mentioned that a dues reminder has been added to the webpage and encouraged members to check the webpage time to time for new information. She also asked if someone would volunteer to take over this responsibility as she is unable to continue in the coming year.

**Refreshments** – Chmn. Christine Bouldin noted that Wilma Davenport and Martha Holt provided the refreshments for today's meeting.

### **Pioneer Families**

The remaining certificates will be issued at the January meeting of the Association. The Board of Directors has discussed the viability of leaving this option open-ended so that at any time in the future, anyone could apply for and receive a certificate by mail if qualified. No further ceremonies would be planned. After a brief discussion, a motion was made by Wanda Gant, seconded by Ladye Hunter, to continue issuing these certificates as long as anyone is interested.

### **Birthing Tree Keepsake**

Approval has finally been received from Mayor Haley to use the birthing tree as our next keepsake. Pat Berges presented a proof of the proposed keepsake. General consensus was that the keepsake should be larger (in line with our other keepsakes), the ground under the tree should be flat, and the lower branches should droop more. Pat will follow up with the supplier to make these changes and a revised proof will be requested.

There seems to be some question about the church purchasing all of these keepsakes. It was decided we should ask the church to announce the keepsakes in their member newsletter, and we should also issue public notices in the local news media about them.

### It's not too late to get your certificate! Applications will be accepted through December 31, 2013 Join the 34 recipients who received Certificates in July for Warren County – McMinnville First Pioneer Families

To qualify for a certificate, suitable for framing, the applicant must directly descend from an ancestor (male or female) who was in Warren County no later than the 1820 census (this includes the boundaries of the original formation of Warren County from White county).

Proof can be established by submitting copies of an official record, i.e. birth, marriage, death, probate or will, church, cemetery, funeral or obituary, land recodes, tax records, court, military records, census, newspaper, or Bible for each generation, including the applicant. Current Tennessee residency is not necessary.

There is a \$10 application processing fee + \$3.50 shipping for the certificates. All applications and verifying material become the property of the Warren County Genealogical Association.

Applications may be obtained on our web-site at tngenweb.org\wcgatn or Facebook page, WCGA office at 201 Locust St., or the Senior Center at 809 Morrison St. and should be submitted to Warren County Genealogical Association, c/o First Pioneer Families, P. O. Bo 411, McMinnville TN 37111.

Don't delay, certificates will be presented once again at the January 18, 2014 meeting of the WCGA.

## Larry C. Boyd talks about His Austin, Boyd Ancestors

Larry Boyd presented a brief review of his Austin and Boyd families at the November meeting. Nathaniel Austin, his maternal side of the family, came to Middle Tennessee from Charlotte County, VA in the early 1800s eventually connecting with the Boyd family here in Warren County.

He recited several memories of his grandfather F.C. Boyd Sr. and a couple of those are as follows:

### A Memory of F.C. Boyd Sr.

When I was a boy, we lived on my grandfather's farm across the road from Mr. F.C. Boyd's nursery. In the fall his nursery bought seed to

plant. My buddy and I thought we'd make us a little spending money by collecting seed. We got my little red wagon and filled it up with peach seed from Grandfather's farm. Then we headed down Morrison Road, as it was then called, pulling the little red wagon toward the nursery packing barn.

Arriving at the nursery, we looked for the man in charge of buying seed. Mr. Jesse Nunley was usually the man who checked and approved the new seed purchases. When we found him and told him what we had, he abruptly stated, "We've bought all the peach seed



we need this year." Our spirits sank. It seemed that we had done all that seed collecting for nothing. Then Mr. Boyd walked up, patted me on the shoulder and said, "Now Jesse, we are going to buy Bobby's seed." Our spirits were renewed, we sold our seed and we walked home with our pockets jingling with the seed money. Mr. Boyd was a fine man."
