The July 15 meeting of the Warren County Genealogical Association was devoted to the very popular "Show & Tell" program. This is a time when members and guests share their prized family possessions with everyone. Some items are books, pictures and family records while some are family heirlooms passed down from generation to generation.

Carolyn Lance shared



When my husband, Bobby Lance, was twelve

years old his grandfather, Henry Balum Lance died. The farm was sold and his grandmother, America Davenport Lance, "broke up housekeeping" and went to live with her daughter.

Therefore, Bobby did not have any items or keepsakes from his grandparents.

When his uncle, Scott Lance, died his property including all household items was put up for auction.

I went to the auction. Talked to Scott's children and asked them if something came up that belonged to their Lance grandparents and they were not going to bid on would they tell me.

When this crock was put on the table for bids, the daughter turned and said "That was Grandma's". When I got the crock home and we were looking at it, I realize I could not have bought anything better.

It has a crack that I can feel on the inside. The crock was important enough that someone and I almost sure it was Bobby's Grandpa, who had a small blacksmith shop by the barn, repaired it with these strips of metal and wire.

Balum was the youngest of nine children of Clayton and Matilda Luttrell Lance and at the time of his marriage he was living with his parents and farming the family farm. The young couple moved into the log house with his parents and after their death continued to live there. There is the possibility the crock could have been in use by Clayton and Matilda, Bobby's great-grandparents.







Label: JK (PULV) Jay-Kol Antacid Carminative Laxative - Price, 35 cents - Manufactured by JAY-KOL Company St. Louis, MO, USA.



BOTTLE- PULV Jay-Kol ANTACID CARMINATIVE LAXATIVE

Does for **Hypercidity** (excess acids), 1-3 teaspoons one-half hour after meals. Repeat at half-hour intervals, if necessary, to relieve discomfort from indigestion, gas, acid eructations, sour stomach and nausea.

Laxative dose, one teaspoon. Regulate to suit individual requirements. Reduce for children according to age. Maximum adult dosage for 24 hours, three teaspoons. Stir well in plenty of water and drink quickly.

Note: Keep cap on jar air-tight. Shake well occasionally to keep powder light and fluffy.





Jay-Kol Company, Keytesville, MO. Incorporated under the laws of Missouri. 1927. Authorized Capital Stock: 17000 shares Common Stock, par value \$10.00 per share. 7500 shares Preferred Stock, par value \$10.00 per share.

On 28 June 1928 John K. Jaco was issued stock certificate No. 132 for 50 shares of Preferred Captain Stock. The certificate is signed by Luther E (Edward) Jaco, Secretary-Treasurer and his father, E. L. (Estill Luther) Jaco, President. John K (Keith) Jaco gave his valueless stock certificate and empty bottle of Jay-Kol to Allen Jaco shortly prior to his death, as he had no heirs.



Luther Edward Jaco was born 26 Jan 1905 in Bunker Hill, Russell Co., KS and in 1930 married Louisianna Weber.

Luther's parents were: Estill Luther Jaco, b. 8 Apr 1879 Chariton Co., MO and Mary Emma "Mae" Jaycox, b. 8 Dec 1877 or 1880 Elkhorn, KS, d. 12 Jun 1969. Estill L. was a Major in WWI, a school teacher, engineer, creator of the laxative Jay-Kol in 1927, which ceased production during the depression years.

Estill's parents were Jeremiah Allison Jaco, b 26 Oct 1852 in Warren Co., TN, d.23 Jun 1923 in Chariton Co., MO and Cornelia Bell Welch, b. 12 Nov 1861 MO, d. 13 Aug. 1950 Chariton Co., MO. He was a farmer.

Jeremiah A.'s parents were Oliver Riley Jaco, b. 8 Sep 1823 in Roland, Warren Co., TN, d.4 Aug 1908 in Salisbury, Chariton Co., MO, a farmer and Civil War vet in CSA from Missouri and Caroline Gribble, b. 2 Oct 1830 Warren Co., TN, d. 23 Nov 1861 in Chariton Co., MO, she was the daughter of John Carmack Gribble and Susan Lucinda Roberts, daughter of Reuben and Mrs. Mary Millie Asher.

Oliver's parents were Jeremiah Jaco, b. 7 Jan 1783 MD, d 11 Oct 1869 in Warren Co., TN, and his wife, Francis Annie Boykin, b. 25 Mar 1781 in Edgecombe Co., NC and d. 1 Aug 1874 in Warren Co., TN. Both parents are buried in the Jaco Cemetery, Campaign, Warren Co., TN. Jeremiah was a farmer.

Jeremiah's parents were John Jaco, b. abt. 1740-50 MD, d abt. 1819-1823 in Warren Co., TN, without a located grave stone. Jeremiah's mother is unknown. His father married last in 1806 to Thomas Boykin's widow, Elizabeth, and together they had no children. Thomas and Elizabeth were also parents to Jeremiah's wife, Francis Annie Boykin. Jeremiah married Francis the same month in Logan Co., KY as did his father marry Francis' mother, Elizabeth. Francis'

unmarried sister, Celia Boykin, is buried beside her in the Jaco Cemetery.



Joshua Roberson shared a watch which belonged to his great grandfather's brother, his great uncle Howard Robertson. Howard was an employee of the Nashville, Chattanooga and St. Louis (NC&StL) Railroad Co. in Nashville, as a Fireman. A Fireman was the man that shoveled coal into the firebox of the train. The watch is an 18 size, Elgin, B.W. Raymond, 19 jewel watch in a Gold Filled Philadelphia Watch Case Company case. It was manufactured in 1905 in Chicago, where Elgin was located. Joshua's

mom and her sisters discovered the pocket watch with some of his uncle's belongings when cleaning out his grandparents house a few years ago. Uncle Howard lived with his Robertson grandparents, in Mt. Juliet, TN, up till his death in 1970.




# Warren County – McMinnville First Pioneer Families

There's still time for you to make your connection by submitting copies of an official record linking you to Warren County before 1820. Those records can be birth, marriage,



death, probate or will, church, cemetery, funeral or obituary, land records, tax records, court, military records, census, newspaper, or Bible for each generation, including the applicant.

To qualify for a certificate, suitable for framing, the applicant must directly descend from an ancestor (male or female) who was in Warren County no later than the 1820 census (this includes the boundaries of the original formation of Warren County from White county).



There is a \$10 application processing fee + \$3.50 shipping for the certificates. All applications and verifying material become the property of the Warren County Genealogical Association.

## **Current Tennessee residency is not necessary.**
