Member Surnames Help Prove Some of Us are Cousins

Once again we called on our very own Ann Brown to address our Association at the October 19 meeting of the Warren County Genealogical & Historical Association. The program “Are We Cousins? Our Surname Connections” brought to light how sharing your Surnames with fellow members and researchers can lead you to some surprising finds. Her program proved this to be very true.

Ann emphasized that “we are all cousins” stating that a Family with 2 or 3 children have 190 3rd cousins, 940 4th cousins, 4,700 5th cousins, 500,000 8th cousins and 1 billion 13th cousins. This leaves us all with 8,192 ancestors.

She further states that 1st cousins share grandparents, and 2nd cousins share the same great grandparents.

If you are an avid genealogy researcher, you should want your surnames available to all researchers.

Ancestry.com is a good example with the great job they do connecting us by DNA to relatives through the surnames we have on our family trees on their site.

Our Surname Registry started in 2017 and we have 250 plus names from 16 WCGHA members. This is only 20% and our goal is entries from all of our members.

From those Surnames we have discovered:

J.B. Brown and Cheryl Watson Mingle are 4th cousins through the James W. Bond and Naomi Wright marriage;

J.B. Brown and Marion Rhea Speaks are ½ 5th cousins 1 x removed through Abraham Cantrell;

J.B. Brown and Marion Rhea Speaks are 5th cousins 1 x removed through Achilles Durham and wife Mary Cates; *(photo below on the left)*



Wilma Davenport’s husband Morris Davenport is 4th cousin 2 x removed with Ann Brown’s daughter Krista Mingle, 2nd cousin 1 x removed to Carolyn Lance’s husband Bobby Lance and Bobby is 5th cousin 1 x removed to Krista Mingle. All through Edmond Davenport and wife Lydia Galloway;

J.B. Brown and Bobby Lance are 4th cousins through Michael Alexander Derryberry who was married to Nancy Roseanna Miller;

Ann Brown is 8th cousin 2 x removed to Doyle Speaks through the Thomas Speake marriage to Elizabeth Bowling; *(photo on the right)*

Bobby Lance is 2nd cousin 1 x removed to Morris Davenport through the Clayton Nale Lance married to Matilda Luttrell;

Paul Hobbs, husband to Jean Hobbs, is 2nd cousin 1 x removed to Glenda Cantrell through Christopher Hobbs married to Elizabeth Smith;

Hopewell Cemetery Cleanup in Action

A large crowd of volunteers were hard at it Saturday, November 9 cleaning up the over-grown Hopewell



Cemetery located in McMinnville.

Sunshine, on a frosty 25 degree morning, saw the temps in the 50s by

mid-day. Folks began to arrive at 7:00 a.m. and were greeted by Debra McBride and her family. The crowd began to grow throughout the morning.

A large amount of underbrush was removed along with a lot of growth that had to be cut and removed. This was all pulled to the wood chipper supplied by McBride Tree Trimming & Removal operated by Toby and David McBride. The fallen trees, too big for the wood chipper, were cut into small pieces by chainsaw and hauled away.

It was a welcome site to have the community, alongside the WCGHA members eager to help with this project.

Cemetery Preservation Committee co-chairman Debra McBride, along with Donna Sullivan and Alma Shoemaker chose this cemetery as their first project in an effort to restore respect for those buried there. It is just one of 35 cemeteries in the county on our “forgotten” list.

“This is just Phase 1 for the Hopewell Cemetery. A lot is to be done and we will be back as many times as it takes to complete the restoration” quoted Debra McBride.

The Cemetery Preservation project is a result of the WCGHA “Cemetery Project” that was organized a year ago. Spearheaded by chairman J.B. Brown, along with committee members Ann Brown, Bettye Pack, Mary Oaks, Bonita Mangrum, Carolyn Lance and Evelyn Wade, they began an effort to identify, map, get coordinates, driving instructions and look for deeds for each cemetery.

Walker Appointed Interim Archivist

Magness Library director Brad Walker has been selected as interim archivist for Warren County.

A county archivist assesses, collects, organizes, preserves, maintains control over, and provides access to records and archives determined to have long-term value. The archivist also establishes safeguards against unauthorized removal or destruction of the records.

“This is a temporary position while Ann Brown undergoes training,” said

Walker. “You have to be certified, which I am. Certification takes about three years.”

Brown, who currently holds the title of assistant archivist in training, will begin the certification process and work with Walker to eventually take over the reins.

The two replace county archivist Jean Hobbs, who resigned.

Several years ago Hobbs was instrumental in moving the old county records stored in the basement of the courthouse in damp conditions to an air-conditioned room at Warren County Administration Offices where they can be preserved. She received her training at the Tennessee State Library and Archives.

“It needs to be preserved and I guess it just fell on me to do it,” Hobbs said, at that time. “But I enjoy it. I think it’s really important. That’s why I do it.”

Walker was unanimously approved by the Warren County Commission on Oct. 21 to fill the position until Brown completes training.

Pictured in the Warren County Archive room are WCGHA Past President Ann Brown and WCGHA member Brad Walker. Brad, who is Director of Magness Memorial Library and a certified archivist, has been named interim archivist for Warren County. He will be replaced by Ann when she completes her required training.
