

Everyone enjoyed Laura Beth Gheesling's presentation on the early beginnings of B & P Lamp Supply. Laura is the greatgranddaughter of Pauline Vanhooser Barnes (1911-1996) and Lawson Hill Barnes (1909-1969). Pauline and Lawson both descend from early Warren County families and made their home here. Married in 1930, they lived through the Depression, managed the Dixie Theater and made their home at 112 Westwood Drive. It was in the basement of their home that their business ventures began with the restoration of furniture. Eventually, this business expanded into antiques and finally settled into the specialty of lamp repair and restoration. We enjoyed seeing photos and memorabilia from the beginnings of this family business.




